## **Programme Outline**

Emphasis will be on strategic foresight, risk management, and innovation, aligned with CIBAFI's Principles of Sustainability and Innovation Integration. Participants will explore frameworks and tools to build resilience, ensuring their organizations can withstand and capitalize on market disruptions.

#### 2. Leading AI-Driven Change in the Evolution of Work

As artificial intelligence transforms the business landscape, leaders in Islamic finance must be adept at leveraging AI to enhance operational efficiency and strategic decision-making. This topic aligns with CIBAFI's strategic objective of industry research and analysis, offering insights into how AI can be harnessed to shape the future of work, optimize talent management, and drive competitive advantage.

#### 3. Responsible Leadership in Banking and Finance

Responsible leadership is crucial for maintaining trust and integrity within the Islamic finance sector. This topic will cover the principles of ethical governance, sustainability, and social responsibility, in line with CIBAFI's advocacy for Islamic finance values and related policies. Participants will learn how to lead with accountability and transparency, fostering a culture of ethical behavior and long-term value creation.


